The event occurred on 05/30/2020 at approximately 16:29 at 901 K STREET NW, WASHINGTON, DC 20001

On Saturday, May 30, 2020, at approximately 1100 hours at the intersection of 16th and H Street, NW, a crowd of approximately 200 persons assembled on the street and sidewalks. Through the course of the remainder of the date in question, and into the early morning hours of Sunday, May 31, 2020, the crowed at 16th and H Street, NW began to enlarge to an approximate number of 2,500 persons. This assembly breached the police lines on the north side of Lafayette Park, a National Park Service area. Multiple law enforcement officials from the Metropolitan Police Department, United States Secret Service, and United States Park Police witnessed multiple persons within this assembly throwing items, materials, and burning items toward law enforcement personnel. As the threat towards law enforcement escalated by hostile actions, a large majority of this assembly, approximately 2,000 persons, began to cohesively, in an organized manner, march through the downtown areas of the City. Along the course of this march, persons acting together began to throw materials into the street blocking emergency vehicle responses, setting fires to at least two (2) vehicles, multiple trash cans and dumpsters. Further, these persons assemble together collectively were encouraging each other to injury members of law enforcement. In fact, multiple members of several Law Enforcement agencies sustained a variety of injuries to include lacerations, abrasions, broken bones, and contusions.

Through this tumultuous and violent conduct, that was organized and supported by observers furnishing rocks, bottles, lighters, fireworks became a grave danger of significant property damages and injuries upon bystanders and first responders.

Further, this march, originating from the same assembly, began to break windows of multiple commercial businesses, break and enter these establishments, and while inside unlawfully take merchandise, other materials, and US currency while they unlawfully burglarized these businesses, in which no person assemble or marching had been granted lawful permission to enter upon.

After the use of crowd control measures, in an effort to restore order and reduce the violent conduct that created in grave danger of damage or injury, arrests of these persons, having been individually witnessed by members of law enforcement, was placed under arrest for Rioting in the area of: 970 I st NW.

The defendant was transported to the First District where they were processed, evidence seized, and held in custody.

It was noted that a significant structure fire resulted from the assembly at 16th and H Streets, NW, in which the District of Columbia Fire and Emergency Medical Services had to extinguish. It was noted that looting had taken place at all types of establishments to include technology sales, clothing sales, banking, and restaurants. Reasonable damages may be estimated in several million dollars to make repairs to these locations. Furthermore, the Metropolitan Police Department sustained damage to multiple police vehicles. It was also noted that extensive graffiti had been placed onto City public space to include, roadway signs, bus shelters, trashcans, and public and private building exterior walls.

The event and acts described above occurred primarily in the District of Columbia and were committed as described by defendant(s) listed in the case caption.
